Description of the subject of the public procurement: VJN 03/19** - Works on the construction of three free-standing multifamily residential buildings: Building 3 on the cadastral lot 4412/37, Building 4 on the cadastral lot 4412/38 and Building 5 on the cadastral lot 4412/39 with landscaping around buildings and corresponding landscaping within blocks on the part of the cadastral lot 4412/49 Cadastral Municipality Kragujevac IV, City of Kragujevac,

- 5. The criterion for contract award:** The criterion for the award of a contract under this public procurement is the lowest price offered.

- 7. A way of submitting the offer:** The whole offer has to be prepared in compliance with this Invitation and Tender documentation for the public procurement. Offers are submitted on the forms of Tender documentation in a sealed envelope with a note: **An offer for a public procurement in an open procedure for VJN 03/19 - DO NOT OPEN, OF THE PURCHASER "SPV LEPENICA" Llc, Kragujevac. Offers are submitted at the following address: Building Directorate of Serbia Llc, 110 Bulevar Arsenija Carnojevic Street, New Belgrade.** It is necessary to indicate on the back of the envelope the business name and address of the tenderer.

- 8. The deadline for submission of offers** is 24th of January 2020, until 09:30 a.m.
- 9. Place, time and way of opening of offers:** The opening of offers is on 24th of January 2020 at 10:00 a.m. in the premises of the Building Directorate of Serbia Llc in Belgrade, 110 Bulevar Arsenija Carnojevica Street, Belgrade-New Belgrade. The opening procedure shall be public and shall be done according to the time of the receipt of offers from the earliest to the latest offer received.
- 10. Conditions under which the tenderers' representatives may participate in the offers opening procedure:** The offers opening procedure will be open for attendance of authorized tenderers' representatives who are required to prove their status of the tenderers' representatives by submitting the authorization which is signed and certified by the authorized person of the tenderer to the Committee for public procurement or public procurement officer, immediately before the opening of offers.
